Kingston & Richmond Safeguarding Children Partnership Quality and Innovation Subgroup - Terms of Reference

November 2024

I. Purpose

The Quality and Innovation Subgroup (Q&I Subgroup) is held jointly across both Kingston and Richmond. Multi-agency quality assurance activities are key functions of the partnership and allow us to monitor and evaluate the effectiveness of what is done by our partners individually and collectively to safeguard and promote welfare.

The purpose of the subgroup is to monitor that all agencies are doing the right things at the right time to consolidate or improve outcomes for our children, young people and their families by thinking together, learning together and improving together. This will be achieved by:

- The subgroup will start with the experience of the children and young people in which to inform our practice.
- Examining, challenging, and scrutinising performance and effectiveness in meeting objectives set out in the KRSCP Business Plan.
- Analysing performance data in a consistent way to identify areas of strength and development to inform the subgroup areas of multi-agency work, including through the use of Section 11 safeguarding self-evaluations and partners' annual reports.
- Implementing an annual audit activity programme and reviewing the findings to determine strengths and improvement areas in which to give feedback to all agencies.
- Identifying successes and sharing examples of effective and innovative practice and evidence-based research.
- Considering local practice in relation to the child's journey and effective multi-agency working
 The subgroup's activity will be presented to the Delegated Safeguarding Partners (DSP)
 following appropriate synthesis and analysis which highlights areas of strengths and
 development.

The subgroup will lead on one deep dive per year which will form part of a multi-agency learning event across the partnership. The theme of the deep dive will be in agreement with DSPs. The subgroup will also undertake one multi-agency audit per year to look at previous themes to assure the partnership that learning is embedded and there is evidence of practice improvement. In addition, the subgroup will identify other multi-agency audit work based on trends or other areas of learning and seek to test the results of previous work.

The Quality and Innovation Subgroup operates in alignment with the Working Together to Safeguard Children 2023 Guidance. Safeguarding partners are expected to maintain oversight of the quality of local practice and its impact on children and families. This involves implementing robust quality assurance mechanisms to ensure safeguarding practices are both effective and lead to positive outcomes.

Key aspects of this alignment include:

- Data Collection and Analysis: Effective collection, sharing, and analysis of data enables early identification of new safeguarding risks, issues, emerging threats, and joined-up responses across relevant agencies. (Chapter 2, Paragraph 40)
- The use of Section 11's: to highlight the responsibilities of organisations to ensure that they have robust safeguarding policies and procedures in place. (See chapter 4)

II. Anti-racist and discriminatory practice

Members of the subgroup should have a senior enough role to have influence in their
organisations Members agree to taking actions from the subgroup and ensure actions are
followed up and taken forward.

V. Governance and accountability

- The Quality and innovation subgroup is co-chaired by the Associate Director for Quality
 Assurance and Review, AfC and the Designated Nurse Safeguarding Children Richmond Place,
 NHS South West London ICB. The subgroup chair will report quarterly on activity and
 outcomes achieved by the subgroup to the statutory strategic leadership. The chair will also
 attend the meeting of subgroup chairs.
- Subgroup members will provide an annual update as part of the KRSCP annual report

VI. Subgroup operation

- Subgroup meetings will take place four (quarterly) times per year and members recalled for extraordinary meetings as required
- Subgroup members are expected to attend every meeting. Where there is a legitimate reason for non-attendance, an apology must be sent and a representative nominated to attend.
- Attendance at subgroup meetings will be monitored, and lack of representation from agencies will be highlighted.
- Meeting agendas will be circulated at least five working days before the meeting. Minutes will be distributed to subgroup members after the meeting.

VII. Review

The terms of reference will be reviewed at least every two years, or more frequently, if necessary, to ensure they remain relevant and effective in guiding the subgroup's work.
