

Safeguarding children and young people: Early Years Summer 2023

Children at risk of abuse as cost of living escalates Believe in children

Child abuse figures rise as poverty increases, says research by the Nuffield Foundation. This video recording explains the research. With this in mind, we must.



The charity, Barnardo's warns that families will struggle to afford child care over the summer break, as they struggle to meet the rising costs of essentials.

Polling of 1,191 parents and carers shows this summer will be particularly difficult for families because of the ongoing impact of the cost-of-living-crisis. Almost half of parents and carers (46%) surveyed said they will struggle to afford family holidays and days out. One in four (26%) can't fund activities like childcare and holiday clubs, and one in five (21%) won't be able to afford to time off work to spend with their children. Growing up in poverty means children miss out on opportunities and their physical and mental health suffers, all of which can affect them long into adulthood.

Safeguarding forum on 28 June

Seventy five Early Years practitioners heard about the learning from a local child who sadly died aged 4. The learning from the case, called Child V, was wide spread and across all agencies.

Early Years are encouraged to understand the medical conditions of children in their settings, particularly what might happen if the correct medical care is not received. In the case of Child V too much emphasis was placed on the domestic abuse occurring in the household and not enough focus was given to the health needs of the child, who was being medically neglected by the parents who were not taking the child to his medical appointments.

Failure to attend nursery was put down to the child not being well – and fearful of returning after the pandemic. This learning has led to some settings establishing an attendance policy and process when children don't attend. One setting described a simple video call home to see the child. Having eyes on the child is so important in child protection.

Other learning at the event included training around the Domestic Abuse Act, which you can see here. The forum was also lucky to hear from a training organisation called lifting limits, which offers gender equality training for early years.

If you are interested in learning from real safeguarding practice reviews, this from the NSPCC focuses on themes from the Early Years sector.

Domestic Abuse News



Physical violence is just one type of abuse – domestic abuse can be any behaviour which is used to harm, punish or frighten someone, or make them feel bullied, controlled or intimidated. This includes mental, sexual, financial and emotional abuse and other harmful practices such as female genital mutilation (FGM), so called "honour" based violence and forced marriage.

Child to parent abuse is a relatively new area of domestic abuse that is being increasingly recognised. Despite a commonly-held misconception that teenagers are responsible for the majority of Child to Parent Abuse cases, this is the second year in a row that a survey undertaken by Shrewsbury-based social enterprise PEGS revealed many parents experienced physical, verbal or other forms of abuse when their child was five or younger. Before you take part in the consultation, it would be useful to read this document, which outlines the proposed changes. Do please take part in the consultation as this legislation is highly relevant to you.

New to DSL training coming soon

The Early Years team in AfC is developing some new training which will be available next term for people who are new to being a DSL in Early years. This training does not replace the Level 3 Child Protection training that DSL need to have. Instead it is an additional training specifically to develop:

- an understanding of the role in taking the lead responsibility for safeguarding and child protection.
- The course will provide delegates with clear information regarding the safeguarding systems in the borough of Kingston and Richmond
- The course is for staff who are recently appointed or will soon be appointed to the role
 of Early Years Designated Safeguarding Lead (DSL) or Deputy Designated
 Safeguarding Lead (DDSL) in early years settings.

Working Together to Safeguard Children

This statutory guidance sets out what is expected of agencies, organisations and individuals to safeguard and promote the welfare of children in their area. This new consultation is open until 6 September. The draft new guidance is here and the consultation document is here. Once you have read these, you can feedback your responses to the consultation here.
