Safeguarding children and young people: Early Years Autumn 2023

AfC changes planned for 2024

Achieving for Children is in the process of establishing Family Hubs in Kingston and Richmond. This will see existing Centres and Services being remodelled and co-location with partners being implemented. The current phase is developmental with Local Advisory Boards and working groups established.



There will be one pilot hub in each borough, with an aim to launch these in April 2024 with joined up program delivery and some co-location.

Future hubs will be identified and implemented over a two year period.

Existing referral pathways into Children's Centres, Youth Service, Parenting and Early Help will remain until at least September 2024

Communications about any changes to referrals (as required) will be shared closer to the time. Until then please continue to refer families to existing services as you do now and via the Single Point of Access (SPA)



Ofsted Annual Report published

Ofsted carried out 12,300 full EYR inspections in 22-23. Eighty-five per cent resulted in a judgement of good or outstanding for overall effectiveness. Across all judgements, childminders are more likely to be good or outstanding than nurseries and pre-schools. The report highlights recruitment and retention difficulties for Early Years settings.

Watch out for waterbeads

Water beads, used as sensory toys and decorations, are dangerous for small children, warns the Child Accident Prevention Trust. The beads, which are brightly coloured can



swell up to the size of golf ball if swallowed posing a serious health risk to babies and toddlers. They are brightly coloured and soft to touch, making them especially appealing to the children they may harm. Older children use them in water guns, so please tell your families with older children of the risks and to keep these away from their toddlers and ensure stray beads don't escape from the container.

Toy Box warning



Following the news from America of four year old twin sisters dying from suffocation inside a wooden toy box, parents in the UK are warned of the potential danger these boxes pose. The twin sisters got our of their beds in the night and climbed into their toy box to snuggle up with their soft toys. It is thought the lid closed while they slept, depriving them of oxygen because the cedar wood box became airtight when closed. When choosing a toy box it is always safest to have

no lid at all, but if it does have a lid it must have air holes. It is also important to consider if the contents of the box might block air holes. Boxes, like the one in the picture, are dangerous if a child gets inside.

Toy boxes are a useful way to keep toys suitable for older children out of reach of younger ones, but do advise your families to choose with care and consider safety first.

Domestic Abuse News



Physical violence is just one type of abuse – domestic abuse can be any behaviour which is used to harm, punish or frighten someone, or make them feel bullied, controlled or intimidated. This includes mental, sexual, financial and emotional abuse and other harmful practices such as female genital mutilation (FGM), so called "honour" based violence and forced marriage.

No Fair Start

This report, A Fair Start For All by the New Economics Foundation and The Social Guarantee, says over 1.5 million children in England reside in areas where there are more than three children under five for each early years space. "A Fair Start for All labels these areas as "early education and childcare deserts," encompassing 44% of all under-fives in England. The research shows that most closures occur in already disadvantaged areas with the lowest Ofsted ratings.

Concerns rise as the government plans to expand funded hours, potentially impacting vulnerable children

due to the sector's existing strain. Tom Pollard, the report's author, emphasizes the government's role in funding 80% of provision in England, urging it to benefit those who need it most.

Neil Leitch, CEO of the Early Years Alliance, warns that economically poorer children, who benefit most from early education, are often denied access. Severe underfunding has left nurseries struggling, particularly in deprived areas, leading to more closures. Urgent government action is needed to ensure infrastructure, funding, and a workforce strategy are in place to provide affordable, accessible, and quality early years provision for every child, regardless of background.

The Autumn Budget's impact on Early Years settings Whilst the increase to the national minin



Whilst the increase to the national minimum wage might help with recruiting to the Early Years sector, Neil Leitch, chief executive of the Early Years Alliance, warned that Early Years settings may be challenged to meet new wage responsibilities without receiving extra finances needed to fund them, especialy with the forthcoming roll out of the extended early entitlement offer, which begins in April with 15 hours for 2 year olds..

Financial pressures on Early Years could be compounded compounded by increasing the staff wages without a back up plan to increase funding for Early Years at the same time as expanding the offer from April 2024. You can read about the roll out of increase childcare offer here.
